





Understanding the Registry Patient and Caregiver Initial Application Instructions

Your Qualified Ordering Physician has entered your information into the Medical Marijuana Use Registry.

Step 1: Log in to the Medical Marijuana Use Registry <u>https://mmuregistry.flhealth.gov/</u>.

Step 2: Navigate to the "YOUR CARD" menu option at the top of the page to view your identification card application.

Step 3: Upload a copy of your Florida Driver's License or Florida Identification card under the Proof of Residence section. Click "Choose File." Select the file you wish to upload and click "Open." The document will appear below the "Choose File" button.

Step 7: A new window will open containing the Bill2Pay interface, where you can supply your payment details. Payments by e-check and credit card are accepted. *A \$2.75 convenience fee applies to each online payment.*
